

“Win 6 Free Registrations for the Novigrad Cittanova Run Race” Giveaway Rules

Article 1

AMINESS d.d., Škverska 8, Novigrad, OIB (PIN): 58935879058 (hereinafter: the Organiser), is organising the “Win Free Registrations for the Novigrad Cittanova Run Race” giveaway on the NCRun Facebook page.

Article 2

The purpose of the giveaway is to promote and advertise the Novigrad Cittanova Run race. This promotion will result in rewarding followers of NCRun on its social media channels.

Article 3

The title of the giveaway is “Win Free Registrations for the Novigrad Cittanova Run race” and it will take place from 21 September to 11:59 p.m. on 28 September 2024. The giveaway takes place on the Facebook social media channel at the URL ([Facebook](#))

Article 4

CONDITIONS AND MANNER OF PARTICIPATING IN THE GIVEAWAY:

All natural persons over the age of 18 who accept the conditions and rules of participating in the giveaway set out in these Rules are eligible for participating in the giveaway.

Employees of the Organiser and companies belonging to the same Group as the Organiser, as well as their immediate family members (parents, spouses, children, siblings) are not eligible for participating in the giveaway. The giveaway is promoted through a post and story on the Facebook and Instagram profiles of the race, but it is in no way associated with Facebook or Instagram nor is it sponsored by them.

In order to participate in the giveaway, participants need to post a comment under the post announcing the giveaway on Facebook with an interesting photograph showing how they are getting ready for this year's Novigrad Cittanova Run race, with sports equipment related to running (sports gear, gadgets, exercising in the gym, out on a track, etc.) during the giveaway, **from 21 September to 11:59 p.m. on 28 September**. By entering the giveaway, participants accept the conditions for taking part in the giveaway.

Article 5

GIVEAWAY PRIZE FUND:

The prize fund includes 6 registration fees, 2 for every category of the race, valued EUR 34 for the 5 km race, EUR 50 for the 10 km race, and EUR 70 for the 21 km race. Registrations will only be eligible for use on the day of the race, i.e. 1 December 2024.

The prize will be awarded to the most interesting photograph as chosen by the Organiser's jury made up of three members. The giveaway will have a total of three winners, one per category, and each winner will receive two free registrations.

The prize referred to in these Rules cannot be exchanged for any other products, gift cards, or cash countervalue, and it is not transferable to other persons.

Article 6

SELECTION OF WINNERS:

The giveaway will take place from **21 September to 11.59 p.m. on 28 September 2024**. During this period, the participants need to post their most interesting photograph showing them getting ready for the race, with sports equipment for running (sports gear, gadgets, exercising in the gym, out on a track, etc.).

In the event that the number of participants in the giveaway is smaller than the number of prizes foreseen, the Organiser has the right to award a smaller number of prizes.

Article 7

ANNOUNCEMENT OF WINNERS:

Names of the giveaway winners will be published no later than **30 September 2024** on the race's Facebook page.

By taking part in this giveaway, participants consent to having their first and last names published by the Organiser on the Organiser's Facebook page and official Instagram profile, with no compensation, in written, audio, image and video form.

Article 8

COLLECTING AND DELIVERY OF PRIZES:

The selected giveaway winners will be notified of their prize under the comment they had left on the post announcing the giveaway, as well as via their inbox, where they will receive an e-mail address to which they are to send a message with their telephone number and e-mail address for the electronic delivery of the registration.

The prize will be delivered to the e-mail address provided by the selected winner, no later than 20 days following the publication of the results, i.e. of sending e-mails. This deadline may only be extended if the selected winner is unable to collect/receive the prize for objectively justified reasons, or if they fail to deliver the required personal information, and if the Organiser is not able to deliver the prize due to a force majeure event.

The selected giveaway winner will incur no tax liabilities and/or fees directly connected with the prize.

Article 9

In case of dispute between the Organiser and giveaway participants, the court with subject matter jurisdiction according to the Organiser's registered office shall have jurisdiction.

Article 10

The giveaway may be cancelled due to circumstances out of the Organiser's competence, i.e. those the Organiser could not prevent, remedy or avoid. In case of cancellation, participants will be notified via the race's or Organiser's Facebook site. The Giveaway Rules will be published on the official Facebook site ([Facebook](#)).

Article 11

EXTRAORDINARY CIRCUMSTANCES:

The giveaway Organiser has the right to refuse to reward the prize if:

- the winner does not fulfil the requirements for collecting the prize
- there is reasonable doubt regarding the authenticity of information (false representation)
- it is established that the selected winner did not comply with the rules and conditions of the giveaway
- the event is cancelled due to adverse weather conditions affecting the organisation
